

China-EU Trade





What Europe was busy with during the past 35 years

- I. Deepening the integration Treaty after treaty
- II. Enlargement
 Several round enlargement
 the latest enlargement: big bang
 - market for export, old member states enjoys a comfortable surplus
 - FDI to increase the productivity
 - Improve the EU's competitiveness as a whole
 - Still need to absorb



What China was busy with during the past 35 years

- I. Reform
 - Establishing socialist market economy
- II. Openness
 - Engaging with the globalization
 - a transition economy, but with no model to follow
 - secret of success of 4 small dragons and 4 small tigers: processing trade
 - opportunity: joinning the WTO




Main Charateristics of China's foreign trade

- The coastal 10 provinces take more than 90% of the trade volume
- Top 10 export markets take more than 70% share
- More than 50% export is taken by JV/FDI, 25% by private sector, the remained by state owned company
- Processing trade takes more than 50% of the export
- Trade dependency more than 40%, whereas USA 11%, India 22%



Trade Balance – a triangle











 - Start to initiate FTA negotiation with Japan, even with China Taiwan




Challenges for Europe

 - Asymetric requests




A survey on China's investment intension






